DISCUSSIONS:

Possible Grants: Dave McIntosh has volunteered to investigate and pursue grants to benefit our lakes and/or Association. One such grant regarding soil/watershed issues will be explored during a meeting scheduled for April 29th between Dave McIntosh and a DNR representative.

Mug Earnings: It was suggested and accepted that the \$240 profit Jolyn Strahm earned be held to purchase inventory for other fundraising projects with additional amounts being transferred to fish stocking account.

Job Descriptions: Due to relevance to property owners, it was decided to make available descriptions for LaGrange County Code Enforcement (now a full time position), Surveyor's office, as well as Lake Association.

Fly Creek: A multiple page letter was sent to Jolyn Strahm from Jeff Klebe expressing his concern regarding the board's involvement with performing clear out of Fly Creek. A copy of this letter was provided to all board members.

Treasurer's Report: Given by Dave McIntosh. Accepted as read.

Committee Reports: Fish stocking, kayak club, cornhole tournament, wine and canvas, movie night. Scholarship oversight to apply stricter discretion over applicants and submissions, per Dave Schnieders.

Bouy Funds: By vote, it was decided to move these to Fish Stocking account. Motion to vote by Erik Pearson, 2nd by Tom McCue.
