Diver Down

Do you know what this is? Do you know what to do when you see it? This is a Diver-Down Flag!



It's red with a white diagonal stripe extending from the top left to the bottom right corners and it is typically 12 inches by 12inches square. This signal is used (and required) to warn other boaters of scuba diving and snorkeling activities in the water. It can be displayed on a float or buoy like what is pictured here. But it can also be displayed on a boat from which the diving



activity is taking place. Indiana law requires that scuba divers or snorkelers display a diver-down flag to mark the diving area. The diver must stay within 100 feet of the flag.

Boats must stay at least 150

feet away from the flag unless directly involved in supporting the diver.

Scuba divers & snorkelers should not place a flag in an area already occupied by other boaters or where their diving operation will impede the normal flow of waterway traffic. (IE: within 150 feet of the opening to the channel.) For the safety of the people below the surface, if you see one of these make sure to stay a safe distance away.

Indiana Clean Lakes Program

First samples have been sent to IU. Over the last couple months, we have taken 2 samples from each lake at the same locations. Royer Lake sampling is near the water level marker in front of the Benak's and Fish Lakes were gathered about 20-30 feet from the mouth of Fly Creek. Overall we did see improvement in the Secchi Disc Readings which is a visual reading of the lake's water clarity and overall appearance, but there is room for improvement!
